#### **Foreword**

Climate, deforestation, transparency - the major sustainability challenges in the supply chains cannot be tackled single-handedly. The Soy Network Switzerland recognised this early on. More than 12 years ago, retailers, manufacturers, procurers, environmental organisations and producer and industry associations founded the first sustainability initiative for a "critical" agricultural commodity.

The soy network impressively demonstrates that cooperation among the actors proves its worth even in times of crisis. Agricultural supply chains have been under pressure since the Corona pandemic. The war in Ukraine brought additional distortions, uncertainties and price increases due to bottlenecks in personnel, packaging materials or logistics. The procurement of feed soy was also affected. The prices for GMO-free soy were historically high. Meanwhile, the situation here is somewhat more relaxed again. However, the geopolitical situation remains fragile and countries in the South are feeling the effects many times more than we are.

What we are seeing, however, is that supply chains for feed soy have withstood the stress test remarkably well: The feed soy supply chains have withstood the stress test remarkably well and the values and cooperation among industry players in the soy network have been strengthened. This is to the credit of all involved and cannot be thanked enough. I invite all members to continue working together on solutions for the future with a lot of commitment and new ideas.


## Soy procurement in times of crisis

Already in 2021, the scarce availability of GMO-free soy from Brazil led to peak premiums. With the outbreak of the war in Ukraine on 24 February 2022, commodity prices also climbed to unimagined heights. In March 2022, for example, a tonne of GMO-free soy meal cost over 800 euros, whereas a normal price would be around 350 euros.

Soy Network procurers were challenged to ensure the availability of GMO-free soy while taking a stand on soy imports from Russia. In March 2022, a task force of the Soy Network decided not to make any new purchases of feed soy from Russia, thus eliminating an important source of supply.

In the course of the first half of the year, the situation on the procurement markets eased. Premiums for GMO-free soy decreased because the price explosion dampened demand in Europe and many countries and market players refrained from switching to GMO-free feeding.

This suited the Swiss procurers. Despite considerable problems with feed procurement, the industry was able to maintain Switzerland's supply of GMO-free animal feed and the quality specifications, sourcing the majority of feed from neighbouring countries.

## Soy imports 2022

In 2022, a total of 269,400 tonnes of feed soy were imported into Switzerland. Of this, 259,314 tonnes were soybean extraction meal and 10,087 soybeans. 248,640 tonnes came



from Europe, which corresponded to a share of 92.3%. Imports of fodder soya from Brazil fell to 19,960 tonnes or 7.4%. The trend thus continued.



For the second time, imports were surveyed in cooperation with ProCert. Of the 26 procurers surveyed, 13 did not report any soy imports and two did not respond. 11 procurers covered 94.9% of soy imports with 255,572 tonnes. The certified share among the procurers was 98.6%. ProTerra, ISCC PLUS and Europe Soya were the most frequently applied lead standards.



# Cereals, broken rice, corn gluten and dextrose

In 2022, for the first time, the targets for feed grain and broken rice were controlled for a whole year. In the starting year 2021, the targets only applied to the second half of the year.

A total of 413,017 tonnes of feed grain were imported into Switzerland in 2022. The evaluations of 13 procurers, who are responsible for 85% of the imports, show a pleasing picture. With the exception of two importers, all procurers were able to meet the targets. Broken rice was imported into Switzerland in the amount of 11,712 tonnes. All importers were able to meet the targets. The targets for maize gluten and dextrose were postponed by one year to 2024 due to a lack of supply in Europe.



#### Media

In the reporting year, the Soy Network was mentioned in 95 media articles, 77 of which were in German and nine each in French and Italian (source: Argus). About one third of the articles were online, two thirds print. The media release on the increase of the import share of European soy was mentioned in 20 media. The biggest media response was the members' meeting at which the ban on soy imports from Russia was announced.

#### **Commentary on the financial statements**

The association year ended with a profit of CHF 15'170.19. The association's assets as at 31.12.22 amounted to CHF 46'213.41.

Nine out of ten requested members pre-financed their membership fees and thus the new competence centre. As a result, the Soja Network recorded income of CHF 153,310. On the expense side, costs were lower than budgeted. The expenses for the association's management were higher due to the introduction of the competence centre.
